Application for the *Creative Campus Residential Experience* Living Learning Program

The Program: For the 2010-2011 academic year, the Office of Housing and Residential Education will make rooms available in Vanderbilt/Barnard Hall, apart from the random selection assignment process, for the *Creative Campus Residential Experience* living learning program. *Creative Campus Residential Experience* is designed to engage students across academic disciplines and interests, and to encourage ongoing participation and engagement in cultural programs and initiatives. *Creative Campus Residential Experience* participants are expected to engage fully in a yearlong, explorative learning experience.

Program Goals: The purpose of *Creative Campus Residential Experience* is to integrate art, media, design and creative expression into life at Vanderbilt and contribute to a culture where students, faculty and staff interact to build synergy in the arts across disciplines. This living learning program will provide students a unique context in which to build their creative potential, develop leadership skills, and exercise their expressive voice. Students can surround themselves with innovative thinkers and leave a legacy through creative enterprise. Participants will have an opportunity to build relationships with key community and campus leaders in the visual, literary, media, design, music, film, and performing art organizations through projects, artist-in-residence programs, field trips, and guest speakers. Department of Art chair and professor, Mel Ziegler, will serve as faculty advisor for the program. Participants will interact with Vanderbilt faculty associates and with other Curb Creative Campus affiliates including the Curb Center scholars and interns. Participants will:

- Be open to new experiences and engagement with diverse groups.
- Explore creative enterprise and public leadership in the arts.
- Become collaborators in an inter-disciplinary and cross-cultural exchange.

Program Requirements: By applying to the *Creative Campus Residential Experience* living learning program, each applicant upon acceptance commits to:

- Participate in a spring 2010 session to prepare for program implementation.
- Attend monthly *Creative Campus Residential Experience* meetings.
- Attend monthly salons with the Curb Center scholars and interns.
- Interact with other members of the *Creative Campus Residential Experience* program by participating in service activities or attending cultural events on campus and in the community.
- Actively participate in and contribute to, an individual, small group, or full group project.
- Actively participate in the final evaluation of the program

Application Process: Applications for the *Creative Campus Residential Experience* program (rooms will be singles) should be submitted no later than 4:30 p.m. on Wednesday, February 24, 2010 to the Office of Housing and Residential Education, 4113 Branscomb Quadrangle. When applications are submitted students will sign up for an interview time and date. Interviews will be held March 2 and March 3 between the hours of 3-9pm.

Liability Waivers: Each applicant must sign the waiver included in the application packet. If member is under 18, an applicant's parent or legal guardian must sign the waiver.

Failure to fulfill commitments or to meet the requirements of the *Creative Campus Residential Experience* program may result in the reassignment of individuals to available spaces on campus. Such reassignment will be made at the discretion of the Director Housing Assignments and the Director of Arts & Creative Engagement in consultation with residential staff members and the Director of Residential Education. Individuals who fail to meet program requirements will be formally warned by the Director of Arts and Creative Engagement and be given an opportunity to improve their performance during a specified probationary period. Participants who repeatedly or egregiously violate University policy may be reassigned without the aforementioned probationary period.

RELEASE OF LIABILITY CREATIVE CAMPUS RESIDENTIAL EXPERIENCE

Please submit completed applications no later than 4:30 p.m. on Wednesday, February 24, 2010 to the Office of Housing and Residential Education, 4113 Branscomb Quadrangle. Students will sign up for an interview when applications are submitted. Interviews will be held March 2 -3 between the hours of 3-9pm.

On March 2-3, the Selections Committee, consisting of Vanderbilt faculty members and staff from the Office of Arts & Creative Engagement, will interview all candidates and review the applications. The Selections Committee will recommend applicants for admission to the *Creative Campus Residential Experience*.

By March 10, letters of notification will be sent to all applicants indicating whether or not they have been accepted into the program. Students who are admitted will not be eligible for participation in the regular housing lottery, but will be required to execute the standard Vanderbilt Housing contract for their space in Vanderbilt/Barnard Hall. Students are housed in single rooms. Students would be required to accept/decline their place in the program by, 4:30 p.m. on Wednesday, March 17, 2010.

Students who are not admitted into the *Creative Campus Residential Experience* may participate in any of the lottery events: Towers suites, Morgan/Lewis apartments, Chaffin apartments, Branscomb suite doubles, traditional doubles and singles. Students do not risk anything by applying for *Creative Campus Residential Experience*.

ALL students must submit the online housing application during the period February 8-14. Applications to living learning centers, Greek houses, or for off-campus authorization are in addition to the housing application. The online housing application is mandatory for all students who will study at Vanderbilt in fall 2010.
